Ballard will present a webinar for the American Evaluation Association on July 13. Board members are encouraged to participant in this webinar.

There we be a soft launch of the new website to allow the Board to review the website and provide feedback on its functionality.

Ballard is working on the development of web operating procedures, to be used post launch. These operating procedures will identify roles and responsibilities and explain how decisions are made.

On the new website, there will be a member forum and member blog. The purpose of the forum is to get/provide feedback about specific issue/s. The blog will be focused on a certain topic.

Ballard noted that the JCEP Leadership conference will be held February 8-9, 2017.

Ballard will distribute a Qualtrics survey after today's meeting. Responses to the survey will help prepare for the June Board Meeting. The survey will also ask for specific operating procedures that need to be discussed at the June Board Meeting.
