#### Journal of Extension – Denny

- Journal is fully staffed with 10 volunteer editors and can cover all submission topics.
- Looking to add a senior editor role to be onboarded by next year.
- Student has been creating metadata for back issues, so over 5000 articles can be uploaded to the current website and the old site can be officially archived (moving to a single platform).
- Volume 60 issue 3 will be published soon, keep an eye out.
- Reaching out to every institution to identify a JOE ambassador to help share publications, special topics calls, and highlight authors to directors so that institutions continue to support journal through fees
- Due to a backlog, some approved articles will not be published until 2023, even with the generous limit of 25 articles per issue
- Focus on community engagement and engaged scholarship. Denny has funding for a master's student to do engagement research, please contact her with leads on interested students.
